GRANT OF AD-HOC ALLOWANCE – 2010 @ 50% OF EXISTING BASIC PAY AND MEDICAL ALLOWANCE

I am directed to state that Governor of the Punjab has been pleased to sanction an Ad-hoc Allowance – 2010 @ 50% of the existing basic pay of Basic Pay Scales, 2008 to all the civil employees of the Punjab Government including contingent paid staff and contract employees employed against civil posts in Basic Pay Scales on standard terms and conditions of contract appointment with effect from 1st July, 2010.

2. The amount of this Adhoc Allowance:

- i) will be subject to Income Tax.
- ii) will be admissible during leave and entire period of LPR except during extra ordinary leave.
- iii) will not be treated as part of emoluments for the purpose of calculation of pension/gratuity and recovery of House Rent.
- iv) will not be admissible to the employees during the tenure of their posting/deputation abroad.
- v) will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.

3. The term "Basic Pay" for the purpose of Ad-hoc Allowance – 2010 will also include the amount of the personal pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.

4. This Ad-hoc Allowance will not be admissible to personnel of Punjab Police, Border Military Police, D.G. Khan & Rajanpur, Baluch Levy D.G. Khan, Prisons, Directorate of Reclamation & Probation, Judiciary, and employees of other Departments who have already been allowed an allowance equal to at least one month's initial of pay


4. This Ad-hoc Allowance will not be admissible to personnel of Punjab Police, Border Military Police, D.G. Khan & Rajanpur, Baluch Levy D.G. Khan, Prisons, Directorate of Reclamation & Probation, Judiciary, and employees of other Departments who have already been allowed an allowance equal to at least one month's initial of pay scales i.e. teaching/non-teaching staff of teaching institutes including employees of Directorate of Special Education and employees of MPDD etc.

5. The Medical Allowance in lieu of Outdoor Treatment and reimbursement of medical expenses has been granted as under:

S. No.	BPS	Existing Rate	BPS	Revised Rate
i)	1-16	Rs.500/- p.m.	1-15	Rs.1000/- p.m.
ii)	17-22	Nil	16-22	15% of basic pay

Note: The existing facility of reimbursement of amounts spent on account of purchase of medicines by Government servants and local purchase of medicines by Government Hospitals for Outdoor Patient (OPD) will be discontinued. However, the existing facilities for consultation and diagnostic investigations at OPD will continue as before. Reimbursement/Local Purchase on account of Cancer, Hepatitis B, C and Insulin dependent diabetes would be admissible for OPD patients. The existing facility of reimbursement of all kinds of expenditure on account of Indoor Medical Treatment will continue as before.

6. The above Ad-hoc Allowance - 2010 and Medical Allowance shall be accommodated from the budgetary allocation for the year 2010-2011 by the respective Departments out of supplementary grants to be provided by Finance Department on submission of demands.



SUBJECT: GRANT OF MEDICAL ALLOWANCE TO CIVIL PENSIONERS OF THE PUNJAB GOVERNMENT

I am directed to state that the Chief Minister of Punjab has been pleased to sanction Medical Allowance w.e.f. 01-07-2010 to all civil pensioners of Government of the Punjab at the following rates:

- (i) Pensioners who retired in BPS1-15 @25% of pension drawn.
 - (ii) Pensioners who retired/will retire in BPS 16-22 @ 20% of pension drawn
2. The Medical Allowance will be allowed after allowing increases in pension, family pension and minimum pension notified vide following circular letters:

- (i) FD-SR-III-4-108/2010 (D) Dated 15.07.2010
- (ii) FD-SR-III-4-108 (A) Dated 15.07.2010
- (iii) FD-SR-III-4-108/2010 (C) Dated 15.07.2010

3. The re-employed pensioners will be allowed medical allowance after allowing increases in pension on notional basis as increases in pension are not admissible to them during re-employment.

4. The existing facility of reimbursement of amounts spent on account of purchase of medicines by the retired Government Servants and local purchase of medicines by Government Hospitals for Outdoor Patients (OPD) will be discontinued. However, the existing facilities for consultation and diagnostic investigations at OPD will continue as before, Reimbursement/Local Purchase on account of Cancer, Hepatitis B, C and Insulin dependent diabetes would be admissible for OPD patients. The existing facility of reimbursement of all kinds of expenditure on account of Indoor Medical Treatment will continue as before.





SUBJECT: **GRANT OF INCREASE IN PENSION TO CIVIL PENSIONERS OF PUNJAB GOVERNMENT**

I am directed to state that the Chief Minister of Punjab has been pleased to grant increase in pension with effect from 1st July, 2010 until further orders to all Civil Pensioners of Government of the Punjab at the following rates:-

|---------------------------------------------------------|-------|
| (a) Those pensioners who retired before 01-12-2001 | = 20% |
| (b) Those pensioners who retired on or after 01-12-2001 | = 15% |

2. The increase will also be admissible on family pension granted under the Pension Rules of the Government of the Punjab as well as on the Compassionate Allowance if being drawn by any pensioner.

3. For the purpose of admissibility of increase in pension sanctioned in this circular letter the term "Net Pension" means "Pension being drawn".

4. If the gross pension sanctioned by Government of the Punjab is shared with any Government in accordance with Rules of the Government of the Punjab, the amount of increase in pension will be apportioned between the other Governments concerned on proportionate basis.


5. The increase in pension sanctioned in this Notification will not be admissible on Special Additional Pension in lieu of pre-retirement Orderly Allowance.

6. In case of re-employed pensioners, the increase in pension sanctioned in this Notification shall not be admissible to them during the period of their re-employment but the same will be allowed after the termination of re-employment contract. However, increases in pension admissible to the pensioners of the Punjab Government before their re-employment on contract basis will continue to be admissible to them provided that they are not in receipt of any increases allowed as allowances with their pay in lieu of increases in pension.

7 The benefit of increase in pension sanctioned in this notification will also be admissible to those civil pensioners of the Punjab Government who are residing abroad (other than those residing in India and Bangladesh) who retired on or after 15-08-1947 and are not entitled to, or are not in receipt of pension increase under the British Government's Pension (Increases) Acts, the payment will be made at the applicable rate of exchange.





2. Similarly, family pension allowed to the family of a retired government employee has also been increased from Rs.1000/- p.m. to Rs.2250/- p.m.






2. No arrears on any part of increase in gross or net pension being allowed through circular letters will be admissible in the cases of family pension pertaining to the period prior to 01-07-2010.
