WAIVING OF RECOVERY ON ACCOUNT OF WRONG DRAWAL OF HIGHER SCALE AS WELL AS SPECIAL INCREMENT

As a special dispensation and on the basis of a quota of 33%, a few categories of Punjab Government employees in BS 1-4 were granted Selection Grade (one it to grade up) during the period from 25.05.1991 to 30.11.2001. On 01.12.2001, the settence of selection grade was discontinued and beneficiaries drawing pay in a selection grade were allowed pay in the selection grade pay scales. Subsequently, Punjab Government approved that the employees from BS-1 to BC-4 move one scale up in their respective pay scales w.e.f. 01.07.2007 alongwith one special advance increment in their moved up scales vide notification No.FD.PC.32-7/2007 dated 10.09.2007 & 26.09.2007.

2. The Administrative Departments misinterpreted both of the above mentioned dispensations and their employees already in receipt of Selection Grade were also given the subsequent benefit of moving one scale up thus enjoying a double benefit i.e. an employee in BS-1 in receipt of Selection Grade moved to BS-2 and later to BS-3 by virtue of moving one scale up. Whereas, as per Government's clarification no change was to take place in the position of employees who were already notding Selection Grade i.e. they were neither to be moved another scale up nor were to be granted the special increment vide this Department's clarification of even number dated 22.05.2008. However, some employees wrongly drew and are still enjoying both the benefits, which need to be rationalized / rectified.

- The matter was examined in pursuance of direction of Horible Lahore High Court, Lahore dated 21.09.2011 in writ petition No.15738/2011 and with the approval of competent authority, it has been decided that recovery on account of wrong drawal of higher scale as well as special increment is waived off uptil 30.06.2012 in case of those who are still enjoying both the benefits. As far as the employees whose double benefit has already been discontinued are concerned, they would not be entitled to draw the double benefit as already discontinued.
- Pay of all such employees (mentioned above) will be fixed in the pay scales which were admissible prior to 01.07.2007 accordingly. However, their request for restoration of higher pay scales wrongly allowed is declined henceforth.
