Subject: CONSTITUTION OF ANOMALY COMMITTEE - 2011

I am directed to state that an Anomaly Committee with the following composition has been constituted in the Finance Department (Regulations Wing) to resolve anomalies arising out, on implementation of the Revised Basic Pay Scales, Allowances and Pension 2011 pertaining to civil servants of the Punjab Government:


1. Finance Secretary	Chairman
2. Administrative Secretary (concerned)	Member
3. Secretary (Regulations), S&GAD	Member
4. Additional Finance Secretary (Regulations)	Member
5. Deputy Secretary (PC), Finance Department	Member/Secretary

2. All cases involving anomalies in the revised basic scales or arising out of the fixation of pay in these scales should initially be examined by the administrative department concerned. If as a result of such examination, the administrative department is satisfied that there is an anomaly, it should refer the matter to Anomaly Committee with information in the following proforma:

a) Name of the Administrative Department
b) Name of the office
c) Designation of the post/designation and name of the government servant (if the anomaly is in respect of an individual).
d) Exact nature of the anomaly/difficulty (detailed description to be given).
e) Reasons for considering it to be anomaly/difficulty (detailed reasons to be given).
f) Solution proposed by the Administrative Department with justifications.

In referring the case to the Anomaly Committee, the administrative department should forward six complete sets of papers containing the above information to Secretary to the Committee upto 30.09.2011. The Anomaly Committee shall consider the cases referred to it in a series of meetings. The schedule of which will be notified to the concerned authorities.

4. The Anomaly Committee shall only be a recommending body. The final decision on the recommendations of this Committee will be taken by the Competent Authority.

5. Cases already forwarded in this regard may kindly be re-examined and reported to the Finance Department afresh strictly in accordance with the provisions mentioned in the above.
