SUBJECT: PROBLEMS FACED BY THE PENSIONERS IN SANCTION/DRAWL OF PENSION

I am directed to refer to the subject noted above and state that pursuant to letter of Finance Division, Government of Pakistan, Islamabad bearing No. F.9(3)-Reg.6/2015, dated 13th January, 2017, it has been decided that all Principal Accounting Officers would ensure that no pension case should be withheld for completion of documentary/ No Objection Certificates etc and anticipatory pension may be sanctioned, as mandated in Section 18(4) of The Punjab Civil Servants Act, 1974 which provides as under:

"If the determination of the amount of pension or gratuity admissible to a Civil Servant is delayed beyond one month of the date of his retirement or death, he or his family, as the case may be, shall be paid provisionally such anticipatory pension or gratuity as may be determined by the prescribed amount according to the length of service of the length of



consequent upon such provisional payment, shall be adjusted against the amount of pension or gratuity finally determined as payable to such civil servant or his family".

2. All pension sanctioning authorities are requested to implement the above provisions to facilitate early finalization of pension cases.
