## SUBJECT: PROMOTION POLICY 2010, DEFERMENT IN CASE OF PER DOSSIER IS INCOMPLETE, ESPECIALLY LAST FULL YEAR'S REPORT MISSING

As per para 9(1)(ii) of the Promotion Policy, 2010, the Board / Committee may recommend a civil servant for deferment in case PER dossier is incomplete, especially last full year's report missing.

It has been observed that the officers are being recommended by the departments for promotion in the absence of last full year's report. It may be appreciated that the performance of an officer during the last year is very important to assess his suitability for a higher post. Clearance of such officer for promotion subject to production of PER is a violation of the provisions of Promotion Policy, 2010 and in future no such case should be recommended by the Board / DPC. The Competent Authority has desired that para 9(1) of the policy may be followed in letter and spirit.
