15% quota for women as prescribed vide Notification No.SOR-IV (S&GAD)15-1/2012, dated 21.05.2012.

5% quota for minorities vide notification No.SOR-III(S&GAD)1-35/93, (c) dated 27.03.2010.

20% quota of posts in the cadre of Junior Clerk, Patwari, Driver, Baildar, Naib Qasid, Mali, Frash, Water Career and Chowkidar reserved for the Children of serving / retired government employees in BS-1 to 5, Junior Clerk (BS-7) and Patwari (BS-9) vide notification No.SOR-III(S&GAD) 2-74/2003, dated 05.11.2011.

It has been observed that the Administrative Departments neither properly calculate the total vacancies against the above said quotas nor reflect vacancies against above quotas in advertisements while making general recruitment.
