UP-GRADATION OF DIFFERENT POSTS ON RECOMMENDATIONS OF THE COMMITTEE, HEAD BY THE ADDITIONAL CHIEF SECRETARY

I am directed to state that the Governor of the Punjab has been pleased to up-grade the following posts, in relaxation of ban on up-gradation of posts, with the observations given under the table, with immediate effect:

				scale or on account of time scale promotion or creation of post in BS-16, the incumbents of such posts would continue to hold higher pay scale as personal to them.
13.	Assistant Superintendent, Punjab Local Government Board	14	16	The post is re-designated as Assistant being higher tier of Assistant. Service rules would be amended for exclusion of the post of Assistant Superintendent. After amendment in service rules, the incumbents of the post of Assistant would directly be promoted as Superintendent.

- i) The justification for placing the posts at Serial No.4 to 12 in BS-15 is the prescribed qualification, i.e., Graduation (2nd Division) for fresh recruitment.
- Where the posts were personally up-graded due to having long stay in the same scale, the incumbents of such posts would continue to hold higher pay scale as personal to such incumbents.
- iii) Where the incumbents of above posts were allowed time scale promotion, the incumbents of such posts would continue to hold the same as personal to them.
- iv) Where only one tier is available, the incumbent of posts at Serial No.4 to 12 would be allowed time scale promotion in higher scales after 16 years in case of promotion against BS-17 posts and 10 years in case of promotion against BS-16 posts.
- v) There would be no change in the pay scales of higher tiers of above posts.
- vi) Where the posts at Serial No.4 to 12 were created in higher pay scales, such higher pay scales would be personal to the incumbents.
- 2. The incumbents of the upgraded posts will also stand upgraded and their pay will be fixed at the stage next above their basic pay in their lower pay scales with immediate effect. No premature increment is admissible on up-gradation of posts in terms of policy of Punjab Government.
- 3. The expenditure incurred on the above up-gradation of posts shall be borne by the respective Administrative Departments/Attached Departments. No supplementary grant will be issued in this regard.
