UP-GRADATION OF STORE KEEPING RELATED POSTS ON RECOMMENDATIONS OF THE COMMITTEE, HEAD BY THE ADDITIONAL CHIEF SECRETARY

I am directed to state that the store keeping related posts carry different nomenclatures, pay scales and prescribed qualifications as given in columns 'B' & 'C' below. The Governor of the Punjab has been pleased to restructure these posts with prescribed qualifications, pay scales and designations as given in Column 'D', 'E' & 'F' read with observations given under the table:

- i) Where prescribed qualification for the post of Store Keeper is Matric, it would be redesignated as Junior Store Keeper (BS-7) through amendment in the service rules and in case the incumbent of such post is holding higher pay scale that would be personal to him.
- ii) Where the prescribed qualification for the post of Store Keeper is Intermediate (2nd Division) + 25 wpm typing speed, it would be re-designated as Store Keeper (BS-11) through amendment in the service rules and in case the incumbent of such post is drawing higher pay scale that would be personal to him.
- ii) Where the post of Senior Store Keeper is filled by promotion from amongst Junior/Assistant Store Keeper, the rules would be got amended for provision of promotion against the post of Store Keeper instead of Senior Store Keeper.
- iii) Where only one tier is available, the incumbent of such posts would be allowed time scale promotion after each 8 years as detailed above.
- 2. The incumbents of the upgraded posts will also stand upgraded and their pay will be fixed at the stage next above their basic pay in their lower pay scales with immediate effect. No premature increment is admissible on up-gradation of posts in terms of policy of Punjab Government.



3. The expenditure incurred on the above up-gradation of posts shall be borne by the respective Administrative Departments/Attached Departments/Autonomous Bodies. No supplementary grant will be issued in this regard.
