	(ii) in BS-1 to 18	Appointing Authority:  Provided that the Medical Superintendent of a hospital, higher in rank than the employee, may exercise the powers of the competent authority for placing under suspension an employee in BS-1 to BS-17 for the time being serving in the hospital."


