NOTIFICATION

No.SOR-IV(S&GAD)1-2/2021. In exercise of the powers conferred under Section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Punjab Government Servants (Conduct) Rules, 1966, with immediate effect:

AMENDMENTS

In the Punjab Government Servants (Conduct) Rules, 1966:

- (1) In rule 9, for the word "Government", occurring for the second time, the words "Appointing Authority" shall be substituted.
- (2) In rule 15, for the word "Government", occurring for the second time, the words "Appointing Authority" shall be substituted.
- (3) In rule 16:
 - in sub-rule (1), for the word "Government", occurring for the second time, the words "Appointing Authority" shall be substituted; and
 - (b) in sub-rule (1), in the first proviso, for the word "Government", occurring for the second and fourth time, the words "Appointing Authority" shall be substituted.
- (4) In rule 20, for the word "Government", occurring for the second time, the words "Appointing Authority" shall be substituted.
- (5) In rule 21, for the word "Government", occurring for the second time, the words "Appointing Authority" shall be substituted.
- (6) In rule 23, in sub-rule (1), for the word "Government", occurring for the second time, the word "Appointing Authority" shall be substituted.
