<u>CLARIFICATION REGARDING VERIFICATION OF NO INCOME</u> <u>CERTIFICATE</u>

I am directed to refer to policy letters of this Department bearing No.FD.SR.III-4-111/89, dated 22.07.1989 and No.FD.SR.III-4-57/2013, dated 15.05.2013 (copies enclosed) and state that both of these policy letters contain the condition of having no regular source of income upon receiving of family pension to the un-married daughters, widowed daughters, divorced daughters and un-married sisters of a deceased pensioner/civil servant. However, a question has arisen that who will be the competent authority for verification of 'No Income Certificate' for sanction of family pension in such cases.

3. The matter has been examined in the Finance Department and it is clarified that it is for Pension Sanctioning Authorities to fulfill this condition while sanctioning family pension cases.
