INCENTIVE ALLOWANCE IN PROJECTS / PROGRAMS, POLICY UNITS / POLICY CELLS / COMPANIES / AUTHORITIES, FOUNDATIONS / FUNDS, COMMISSIONS, PUNJAB INFORMATION TECHNOLOGY BOARD (PITB) AND ADMINISTRATIVE DEPARTMENTS AGAINST NON-CADRED POSTS

In continuation of earlier policy letter of Finance Department bearing No.FD.SR.II/9-131/2020, dated 05.10.2022 and to state that the Competent Authority i.e. the Chief Minister has been pleased to approve the following amendments in this policy letter **with effect from 15.03.2023.**


In Para-2 (c) & (d) shall be added as under:

- (c) Administrative Department is allowed to grant Incentive Allowance to in-service regular Government Servants so appointed / posted i.e. from the date joining in Companies / Authorities / Foundations / Funds, Commissions, PITB and Administrative Departments against non-cadred posts, (Non-development side) @ initial stage of Incentive Allowance, as per his / her respective Basic Pay Scale. In case, there is a difference with reference to his / her basic pay being previously drawn and the initial stage of Incentive Allowance then Administrative Department may forward the case to Finance Department to place before the Selection Board for its consideration / recommendations accordingly.
- (d) All other allowances such as, cadre / department / post specific allowance, if any being drawn by a deputationist, including Deputation Allowance will be discontinued.

2. Moreover, para-2(b) of the aforesaid letter is clarified that those officers who opted for Incentive Allowance rather Executive Allowance in terms of para-2(b) of Finance Department's policy letter bearing No.FD.SR-II/9-131/2020 dated 05.10.2022, shall now be entitled for Executive Allowance only w.e.f. 20.04.2023 in the light of Notification, of Finance Department bearing No.FD.PR.12.-7/18(2023), dated 14.06.2023.

3. All remaining terms and conditions in this regard shall remain the same.

4. All Administrative Secretaries are requested to ensure implementation of the above mentioned conditions.




